Dear Sir / Madam,

**Statutory Consultation for the proposed shared-use cycleway facility, Beaconsfield ;
between Grenfell Road and Ledborough Lane; and on-road cycle route, along St.
Michaels Green and Caledon Road.**

You may recall that in recent years, the Beaconsfield Cycle Network has been implemented by Buckinghamshire County Council (BCC), Sustrans (the Sustainable Travel charity) and Beaconsfield Cycle Paths Action Group, (www.beaconsfield-cycle-paths.org.uk).

This involved developing a new cycle network for the town, and new cycle links to the station.

This letter is to inform residents of further cycleway proposals that extend the current cycle network. These proposals are shown on the attached consultation scheme plan, and this letter forms the start of the scheme's formal three week consultation process.

The purpose of this scheme is to extend the existing cycle network with a useful new link, and also create a safer environment for pedestrians and cyclists, and to provide a safe cycle facility for school students.

You will find the "Survey Monkey" online questionnaire for the scheme proposals at the Bucks CC web site ; <http://www.buckscc.gov.uk/Have-your-say> (Click on "**view current consultations**"). Within the survey, you will be requested to indicate whether you support or object to the proposals. Any objections must include a comment, as back up to your view.

You can also view the consultation documents at the Beaconsfield Town Council offices, Monday to Friday between 09:30 and 12:30.

Please respond to the on-line consultation by Friday 24th March 2017.
